2012 Training Schedule

YOU ARE REQUIRED TO ATTEND EVERY TRAINING SESSION. If you miss a session and have had your absence excused by Judy, you are responsible for making arrangements with Judy for making up the material at a later date. She may require you to attend a training class offered to caseworkers and other professionals, which may **significantly delay** your being able to take a case.

We hope all sessions will be held at Main Library, 325 N. Michigan Street, Toledo, Ohio 43604 in the second floor McMaster Center Auditorium. Please confirm the location before you attend day one. On Friday, January 20, we will walk (or you may drive) in the late morning to the Juvenile Justice Center “(JJC)”, 1801 Spielbusch Avenue. On Friday, February 3, we will walk (or you may drive) in the afternoon to Lucas County Children Services “(LCCS)”, 705 Adams Street, on the corner of Adams and Erie Streets. The JJC and LCCS are each about 2-3 blocks from Main Library. **Wear boots for walking.**

A Note about Homework:

Homework for each day is noted in blue italics. To avoid feeling over-whelmed by the huge amount of material to learn, we highly recommend that you read the entire Training Manual prior to the first class! Then you can re-read or review each chapter prior to covering the material in class.

Three of the homework assignments may require some advance preparation depending on whether you have easy access to a computer, whether children reside with you, and whether you live on a bus route. Note that by Jan. 21 you will have taken the race Implicit Attitude Test online, by Feb.3 you will have interviewed a child pursuant to Activity 8A on page 8-2, and by Feb. 4 you will have taken a bus to your assigned agency to pick up brochures.

This training has been partially funded through a contract between Ohio CASA and the Ohio Department of Job and Family Services. **OHIO CASA** supports local CASA/GAL programs throughout Ohio with training, technical assistance, legislative support, and standards implementation so volunteers may advocate for abused, neglected, and dependent children in the court system. COURT OBSERVATIONS

Each person is required to observe the following 4 proceedings:

- 1) Emergency Shelter Care Hearing (ESCH),
- 2) Mediation,
- 3) Drug Court Staffing and part of Drug Court, and an
- 4) Adjudication/Disposition.

You have the option to observe additional hearings, such as a Permanent Custody Hearing. Please coordinate with the CASA secretaries to observe the court proceedings listed above. *After each hearing you observe, please complete an Observation Handout and Checklist and return it to the CASA secretaries immediately after the observation. Completion of the Observation Form is required for each observation.*

Docket time is reserved for ESCHs at 1:00 p.m. each day. Call the CASA office after 11:00 a.m., to find out if there will be an ESCH on that day. Arrive by 12:30 p.m. so that you can observe the interviewing in preparation for the ESCH. Drug court staffings begin between 12:45 p.m. and 1:30 p.m. on Mondays & Thursdays in Training Room 3. You may arrive at 1:15 p.m. regardless of what time the staffing begins. Drug Court begins at 2:30 p.m. (immediately after the staffing meeting) in Court Room 1. Please observe at least a half hour or more of each of the staffing and Drug Court itself. The CASA secretaries can tell you the dates and times of all other hearings. Please contact the Mediation Department directly to secure an observation time for Mediations.

If you are asked to identify yourself for the record, say “your CASA name and CASA observer.”
